2.1 Information on a special professional status

Applicant consortia consisting of at least one city planner and one architect and one landscape architect, as well as applicants that have the three professional qualifications indicated, are entitled to take part in the competition. The certification must come from an EEA / WTO / GPA nation.

Natural persons living in the certification area who are entitled to bear the professional designation of city planner, architect / landscape architect on the date of the announcement and who are members of a Chamber of Architects in Germany, or who are entitled to bear the professional designation of city planner / architect / landscape architect according to Sec. 2, Sec. 7 BauKaG NRW (non-resident architects / landscape architects), and whose business location/residence is in the territory covered by the EEA agreement or in another third state, if it is also a member of the WTO service agreement, or to bear the professional designation of city planner / architect / landscape architect under the law of their respective home country and located in one of the aforementioned international territories are entitled to participate. If the professional designation is not legally regulated, then the professional requirements are determined based on the relevant EC directive. Legal entities are entitled to participate if their business purpose includes performing planning services that conform to the task of the competition, and if the authors of the competition dossier working in the company that fulfil the requirements above.

Applicants can be one or more natural persons or legal entities. If participants are entitled to perform the relevant services according to the legal regulations of the country in which they are located (country of origin), then they may not be rejected solely because they must be either a natural person or legal entity according to the relevant German statutory regulations.

Applicant consortia / companies with subcontractors must complete a joint participation application. **Duplicate participation by individual members of an applicant consortium are not permitted, and will result in the exclusion of all affected applicant consortia from the further proceedings;**
- d) Small office organisations and early career professionals will be informed of the option to form applicant consortia;
- e) Applications that do not fulfil formal requirements or are not signed in a legally binding manner or participation applications not submitted in a timely fashion will result in the application being excluded;
- f) The composition of the prize jury and statutory competition participants named are not final. The awarding authority can change the composition and add individuals / participants.
- g) Applicants / participants are responsible for independently reviewing their authorisation to participate according to RPW 2013 Sec. 4 para. 2 (barriers to participation).
